SUBJECT: National Disability Employment Awareness Month and the AbilityOne® Program

On September 30, 2014, President Obama proclaimed October as National Disability Employment Awareness Month. "Expect. Employ. Empower." is this year's theme. It provides a tremendous opportunity to recognize employees with disabilities and celebrate the AbilityOne Program, which enables more than 45,000 Americans who are blind or have other significant disabilities to find meaningful employment on Federal contracts. This includes more than 3,000 veterans and service-disabled veterans who perform work on these contracts.

For over 75 years, the Program now known as AbilityOne has provided a wide variety of quality goods and services for the defense mission. The Department of Defense (DoD) remains the leading customer of the Program, procuring more than \$1.7 billion in business during FY 2014, which equates to 62 percent of AbilityOne's sales and an estimated 30,000 jobs for people with disabilities. The Federal Acquisition Regulation, Subpart 8.7, prescribes the policies and procedures for purchasing from AbilityOne sources to satisfy procurement needs. AbilityOne is a procurement program with a purpose. In this environment of reduced budgets, your continued support of AbilityOne is critical to provide individuals with disabilities every opportunity to contribute to our great Nation and lead independent lives.

I congratulate them and express great appreciation to the members of the defense acquisition workforce for providing people with disabilities the opportunity to support our mission.
