# FY22-26 Strategic Plan Update

- 2nd generation Cooperative Agreements
- Updated Commission guidance for NPA Recommendation Process (51.301, 51.301-02, 51.301-04)
- Updated data collection forms

### **Overall Implementation Status**

- 16 measures fully implemented
- 12 measures initiated or partially implemented







New Strategic Plan will be issued in early 2026

- Draft plan required by Government Performance and Results Act (GPRA) Modernization Act of 2010 and OMB
- Developing strategic objectives and other core aspects
- Public input will be requested later this year
- Draft plan will be submitted with FY 2027 budget request to OMB (subject to updates in Administration guidance)
- New plan will be ready for release with President's Budget for FY 2027

# **Data Collection Forms Rollout**

#### **Bottom Line Up Front**

- Commission received authority from OMB to use 3 new data collection forms
- Commission working with CNAs to establish process for NPAs to submit forms electronically
- Collectively, new forms and process for submitting data will increase efficiency, accountability, and transparency





# Data Collection Objectives

# Data enables Commission to assess compliance and demonstrate value

- AbilityOne employs individuals with <u>qualifying</u> disabilities, and AbilityOne employers meet all other applicable laws
- AbilityOne delivers quality, mission-critical products and services, on time, like other Federal contractors
- Employees working on AbilityOne Federal contracts receive appropriate accommodations and job supports
- Benefits of the Program accrue to the U.S. economy and labor force





# Disability Qualification Determination (DQD) Form

- DQD form is first of 2 forms that replace Commission's Individual Eligibility Evaluation (IEE) form for reporting employee information
  - Documents NPA's determination that an employee meets the criteria of a qualifying direct labor employee
  - For employees with permanent disabilities, the form will be filled out only once
  - Streamlined design and instructions will save time and increase consistency of disability determinations

# Participating Employee Information (PEI) Form

- PEI form is second of 2 forms that replace existing IEE form
  - Provides data on employees' disabilities, job supports and accommodations, and when applicable, career mobility information
  - Supports streamlined data submission by NPAs to maintain qualification to participate in AbilityOne Program
  - Fulfills requirement for annual employee evaluations IAW Commission regs 41 CFR 51-4.3(b)(7) and 51-4.3(c)(2)

# Annual Representations and Certifications (ARC) Form

- ARC form updates the existing Annual Representations and Certifications Form
  - Documents overall compliance with Program qualification standards by the AbilityOne Federal contractor
  - Provides aggregate data pertinent to Commission statutory requirements (e.g., direct labor hours, wages paid, placements)
  - Certification by AbilityOne Federal contractor's senior leaders that data is accurate and complete

# **Process for Completing Forms**

- As required by Cooperative Agreements, CNAs developing electronic systems and dashboards
- Forms will be submitted electronically via the appropriate CNA-provided system
- CNAs will conduct review and approval of forms, data, and supporting documentation
- Commission oversight will be facilitated by realtime access to the data





# **Projected Timeline for Rollout**

- CNAs will continue with systems design and build; testing planned for May-September 2025
- Projected launch dates
  - Oct 1, 2025: Disability Qualification Determination (DQD)
  - Oct 1, 2025: Participating Employee Information (PEI)
  - Jan 1, 2026: Annual Representations and Certifications (ARC)
- Transition in FY26 from IEE and quarterly data reporting to new forms



### **NSITE Vocational Rehabilitation Partnerships**





## **Overview**

- Network of 66 federal contractors manufactures products for the government
  - Located in 31 of 50 states
  - State of the Art, automated manufacturing facilities
  - Additional federal contractors available to support as needed
- Capability and Capacity to manufacture apparel, chemical/biological protection, medical, food, hardware, and office products to meet federal requirements
- Support warfighter needs (Army, Air Force, Navy, Marines)
- Provide rapid developmental and prototyping projects



# **Apparel & Equipment**

#### Provide a wide variety of apparel and individual equipment to support military and civilian needs

- Combat Ensembles & Dress Uniforms
- Cold Weather Clothing Systems
- Hats, Hoods, Balaclavas, Boonies
- Backpacks, Vests, Load-bearing equipment

# **Chemical/Biological Protection**



- ARTC (All Range Tactical Clothing) Ensemble (6-layer system to support warfighters to -60 degrees F). This is the 3rd generation of cold weather clothing systems that SourceAmerica and NIB have helped to develop.
- IOTV (Individual Outer Tactical Vest) repurpose

   helped Army to save funding prior to
   adopting the MSV (Modular Scalable Vest)
- Various Ammunition Pouches and Bags
- Improved Individual Equipment MOLLE4K pack, ATAP (Advanced Tactical Assault Panel)
