Each Federal Agency celebrates National Disability Employment Awareness Month (NDEAM). This program celebrates and recognizes the talents, skills, and dedication of those disabled Americans who are a vital part of our workforce. In addition, the NDEAM promotes the recognition of individuals who support the Javits-Wagner-O'Day (JWOD) Program and encourages dissemination of knowledge about JWOD capabilities. The Marketing and Regulatory Programs (MRP) has designated the month of January to recognize, celebrate and highlight the JWOD Program.

The JWOD Program is a unique Federal acquisition program which employs more the 45,000 Americans who are blind or have other severe disabilities. Throughout the fiscal year, every employee should:

- Learn more about JWOD Program;
- Find ways that nonprofit organizations participating in the JWOD Program can assist us in meeting our needs for quality goods and services; and
- Put increased emphasis on procuring goods and services from the JWOD contractors.

The MRP is committed to an annual increase of JWOD acquisitions of at least ½ percent of total procurement expenditures per year in accordance with departmental regulations. We should all commit ourselves to greater utilization of the JWOD Program, thereby creating new opportunities and employment for persons with disabilities. In particular, purchase cardholders should always buy items on the mandatory Procurement List from JWOD vendors before considering other commercial sources. The Acquisition Community is encouraged to support the JWOD Program whenever possible.
